Today's newsletter is the most important one I have ever written. Read it carefully. Q2 begins on April 1st, which is April Fool's Day. You might even receive it on the 1st, but it is not a trick. The trick is that this is the quarter when it all flips in gold's favor. Those who are still holding onto the belief that the US economy and US dollar remain in their global dominant position are in for a big surprise this quarter.

This is the two-year anniversary of COVID. Amazingly, it is still with us, and many people are still working from home. In fact, I continue to ignore the economic statistics, such as the unemployment rate, PMIs, housing starts, income increases, retail sales, etc. These data points continue to be unreliable. Perhaps by Q3, we can begin to refer to them once again.

I don't think we realize how much of an impact COVID, inflation, and now the Ukraine invasion has had on the US economy. And this impact is 100% negative, which is hugely beneficial for gold. Perhaps these negative effects can be overcome in H2 or 2023, but as of now, gold has a floor underneath it.

The S&P 500 is only down 5% (a small correction) as March concludes. Many on Wall St are actually bullish that this correction is just about over, and the risk-on trade will continue very soon. Jim Cramer said last week that the bear

market is over. Well, we all laugh at Jim, but he is part of the conventional wisdom on Wall St. But, to set the facts straight, this correction never made it to a bear market, which is considered down 20%. The NASDAQ was down 20%, but the DOW and S&P 500 never confirmed this level.

I believe that a bear market is coming soon, along with a recession. The damage to the US economy is severe. The damage from COVID, inflation, and the Ukraine invasion will not go away easily. Inflation is going to rage all year, and COVID has disrupted business to a high degree. A recovery won't appear overnight. Wall St seems to be stocked up on hopium pills and has become delusional. I suppose I could be wrong on this call, but I don't see any growth in the US economy or in stocks for the rest of this year.

Until Ukraine was invaded, I thought that perhaps the economy could recover in H2, but I'm becoming very skeptical of that outcome. There is simply too much damage from COVID, inflation, and Ukraine. Perhaps without the Ukraine invasion, we could have recovered in 2022, but now the odds are terrible for a recovery this year. Who is going to bet on a recovery? Not many. Perhaps Jim Cramer and a few of his cadre on Wall St.

What has COVID, inflation, and the Ukraine invasion done to the economy? With COVID, you have a plethora of small businesses that have closed. You have a plethora of small, medium, and large-sized businesses that have not returned to full strength. You have a plethora of workers who have not gone back to work or don't want to (creating a worker shortage). You have supply chains broken or damaged. You have banks unwilling to make loans. All of this damage is real and occurring right now.

As for inflation, it is raging not just in the US, but globally. Here in the US, the inflation rate is around 10%, and is higher for many in the lower and middle

class, who are more likely to be renters. Plus, they spend a large portion of their budget on rent, food, and energy. Inflation is a problem for them. I read where 20% of Americans currently do not have enough money to pay their monthly bills. I also read that 6% are currently late on their rent or mortgage.

Inflation causes recessions. In the 1970s and early 1980s, we had three recessions from inflation. Will it be different this time? Not likely. Inflation stops discretionary spending and reverberates throughout the economy. Plus, the Fed and Congress are unlikely to send out stimys (stimulus checks) to offset the high cost of inflation. That is just putting gasoline on the fire. But they might do it anyway!

Ukraine might harm the economy more significantly than COVID or inflation. Why? Because the petrodollar is busy dying. For the first time ever, Europe began paying Russia in Euros or Rubles for their oil and gas. Before the invasion, they paid in dollars using SWIFT. Russia has stopped accepting dollars for payment. Many oil and gas exporting countries will likely follow this move away from the dollar. Did you know that until the Ukraine invasion that Europe paid for its oil and gas in dollars? This is a huge change to the global trade system that has been dominated by dollars since the end of WWII.

And it's not just Europe. Saudi Arabia is in talks with China to accept Yuan for their oil. India is going to buy oil from Russia using Rupees. This is a major global shift away from the petrodollar. The ramifications are huge. The US dollar is busy losing its status as the global reserve currency. This is the moment when gold (and silver) begins to be revalued higher.

Russia announced last week they would pay a fixed price of 5000 rubles for a gram of gold until June 30th (at that time, they will probably change the fixed price). As of today, that is about \$1900 per oz, but if the ruble becomes more

valuable, they will be paying above the USD spot price. Why are they using a fixed price? To effectively move toward some type of commodity-based currency. This is the reset in gold we goldbugs have all been waiting for. This is a huge change if it occurs.

The US banksters have been manipulating gold and silver because they don't want the weakness of the US-dollar dominated global trade currency to become vulnerable. The Ukraine invasion has effectively exposed the dollar as the emperor with no clothes. We have been exporting inflation to the rest of the world via digital money printing (money supply expansion), and the world is now fighting back.

It is awful and tragic that Putin invaded Ukraine and killed thousands of people and destroyed thousands of homes and businesses. I found it repugnant that the world did not send Ukraine help in the way of soldiers. Every country should have sent them 5,000 soldiers to help defend the country. Instead, we sent arms and supplies and told them to defend themselves. If twenty countries sent 5,000 soldiers, this war would be over.

While Putin is a rapacious gangster, he has enough allies to destroy the dollar. He is the needle that is popping the everything bubble. The combination of Russia, China, and India is a very powerful global trading block. These countries want to remove the US dollar as the global reserve currency. They want an alternative to the dollar for global trade, a currency that is not constantly debased.

When the US and its allies placed severe sanctions on Russia, one of those sanctions was to weaponize the global trading system, where the dollar dominates via the SWIFT system. Moreover, they froze any currency reserves that Russia held in foreign countries. This had the effect of telling China that

if they invade Taiwan, their foreign reserves could be at risk. It gave China an incentive to create an alternative to SWIFT and to reduce its foreign reserves.

Once these three countries develop an alternative to SWIFT, the BRICS will likely adopt it. From there, this alternative will spread around the world. This is the moment in history when the US dollar loses its global reserve status. It might not happen all at once, but over the next few years, it will become apparent. And during this period, gold (and silver) will trend higher, perhaps a lot higher.

So, with that backdrop of damage to the US economy from COVID, inflation, and Ukraine, how can you not be bullish gold and silver? I think the floor for gold has risen. Before Ukraine, I thought \$1680 was still in play. Now the floor has crept up. The floor is perhaps as high as \$1850, and once we get back above \$2000, that might be the new floor.

Silver is waiting for gold to break out. I thought with the two weekly closes above \$1950 that gold was off to the races, but the banksters decided to fight back. Little Sis (silver) was the signal that the breakout would take a bit longer. We need Little Sis to start trending higher and confirm the gold breakout. Don't worry, she is lacing up her shoes as I write this. And once she gets to \$27, she is going to increase her pace and perhaps start running.

Last Sunday night, the DXY got to 99. I tweeted that this is the top for the dollar, and now it heads lower. Once it gets to a 94.xx handle, it's over for the dollar. That will be a terminal event. After that, we go under 90, on the way to sub 70.

Several counter tweets argued that I was wrong because the other major currencies are worse off than the dollar. What they don't realize is that there

are trillions of dollars around the world that are heading home, as investors and countries convert their dollars into other currencies. The new meme is, “I don’t need no stinkin dollars.”

This is a worst-case scenario for the Fed. First, we have high inflation, and the US Treasury is trying to sell bonds that have an extreme negative return. Nate Fisher wrote that you have to be a moron to buy bonds at this time. We have 10% (or higher) inflation, and US bonds return around 2%. That’s an 8% loss this year, and what are the odds inflation gets back below 2%?

Second, the petrodollar is dying, and fewer countries want to buy our bonds. The Fed is trapped into monetizing this debt by printing more and more digital dollars, thus adding upward pressure on inflation.

The key here is China, India, and Saudi Arabia. Those three countries are likely going to begin selling their US Treasuries. Japan will get caught in the middle. What do they do? Hold onto theirs (they hold over \$1 trillion in US Treasuries) and take the loss? My guess is that once China gets down to \$500 billion in US Treasury holdings, Japan will begin to sell. At that point, it’s lights out for the dollar, and perhaps lights out before that point in time.

I’ve been writing for years that gold and silver are going much higher (\$3000/\$150) during a once-in-a-lifetime PM bull market. I think it begins now and will last for about 3 more years, perhaps longer.

Let’s look at the gold and silver charts and see how they technically align with bullish fundamentals. Amazingly, these charts are just as bullish. We have an amazing alignment that has been building for years. This tells me that it won’t take much for a mania to manifest. It has become obvious that the gold and

silver are ready to run. The public and investors are going to pick up on it very quickly once it begins.

My guess is that the mania into gold and silver will begin sometime this summer, but it wouldn't surprise me if it begins in April or May. We are getting really close. The signs are everywhere.

The technical chart for gold (see the monthly chart below from 2004 until today) implies that it is very close to breaking out. Could it be any closer? Does that look like a chart that is going to break down? Especially with the fundamental economic backdrop that is currently in place?

As awesome as the gold chart looks, the silver chart (see the monthly chart below from 1979 to today) is my favorite. Look what happens when we get above \$35? Resistance becomes incredibly weak. There will be a magnet to \$50. This (\$35 to \$50) is likely when the mania begins.

Let's finish with HUI (large-cap gold miners index) (see the monthly chart below from 2006 to today). It has a lot of room to run to reach an ATH. We are going to witness an amazing run to an ATH. Can you say whoosh! My guess is that it will only take about 4 big green candles.

That is one of the worst misses I’ve ever seen. I tweeted that the NR (news release) was a train wreck. How did a company that was valued at \$1 billion a few months ago miss this badly? They lost \$18 million last quarter, are almost out of cash, and owe \$168 million. Plus, production was only 7,000 oz in Q4! That is about 1/3 the expectation.

This company will have to dilute severely to survive, and may not.

Top Picks Analyzed This Month

1) 1911 Gold (Late Stage Development): 5-Bagger List. 4/2.5 Rating. They have a permitted mill in Canada, plus a 1 million oz deposit (5.8 gpt). The CEO wants to find at another 200,000 oz before resuming production. Amazingly, its FD market cap is \$19 million. Investors do not like the CEO or the project. The capex for a restart is only \$30 million. They are cashed up with about \$8 million for drilling four target areas. One nice hole and they are off and running.

2) Falco Resources (Late Stage Development): 5-Bagger List. 3/3 Rating. They have a large 5 million oz open project in Quebec. The location is ideal and it has low cash costs. The problem is the capex is too high at \$850 million to produce only 220,000 oz annually. They are hoping to complete permitting in 2022 and obtain financing. I don't know if they can finance the capex. They might have to sell or option the project. The good news is they are getting close to being construction-ready and their FD market cap is only \$85 million.

3) Paramount Gold Nevada (Late Stage Development): 5-Bagger List. 4/3 Rating. They are close to completing permitting on the Grassy Mountain gold project in Oregon. It's not a large mine at 50,000 oz a year, but once in production they will begin to focus on their flagship 4 million oz Sleeper project in Nevada. Sleeper is the prize, but it is low grade and low recovery. As long as gold remains above \$1800, the project is economic. Sleeper will take about 5 years to advance to production, perhaps 6. That's a long wait.

For this reason, I put very little emphasis on the short-term. My ratings are future based (3-5 years). Moreover, if I am wrong about gold reaching \$2500 in the next 3-5 years, then my ratings likely will fall short. Thus, by using a future bias I am introducing a high level of risk.

The Top 25 are the best risk/reward stocks at \$2500 gold and \$100 silver. The Top Picks include stocks that I consider 5+ baggers at \$2500 gold and \$100 silver, have 3 ratings or higher, and do not have any significant red flags. Significant red flags would include high debt, low cash, financing issues, location issues, growth issues, legal issues, timeline issues, management issues, etc.
